**BACKGROUND/COMMUNITY BENEFITS**

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants therefore a benefit results to the County.

The Board of Supervisors is being asked to approve appropriations to Stand Up Placer to help support their *Stand Up and Run* event on October 4, 2014. Stand Up Placer has a 36 year history of providing comprehensive services for Placer County victims of domestic violence and sexual assault and their families. Stand Up Placer operates essential programs for Placer County residents who have experienced the trauma of domestic and sexual violence, and informs the Placer community that a stand is being taken against violence. The *Stand Up and Run* event offers participants 5K and 10K competitive runs, as well as Fun Run/Walk for individuals, families and teams. In the past, *Stand Up and Run* has drawn over 500 participants, and through the years has gained many more supporters from both Placer County and the Sacramento area. Funding received will be used to help cover the costs of the event, and supplies, printing costs, and other items needed to support the programs that benefit the survivors of domestic violence and sexual assault in Placer County.
