**BACKGROUND/COMMUNITY BENEFITS**

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants therefore a benefit results to the County.

The Board of Supervisors is being asked to approve appropriations to help fund the *Placer Sheriff's Activities League Golf Tournament* to be held on September 19, 2014. The Placer Sheriff's Activities League (PSAL) was created in 2012 and was designed to reach out to at-risk and underprivileged youth and offer them constructive activities that will deter them from engaging in criminal or risky behavior. Many of the youths in the program come from economically depressed homes in which violence, drugs/alcohol abuse and/or gang activity are the norm. PSAL volunteers are directly involved in the lives of the youth to help develop leadership and social skills, provide mentorship, and promote teamwork through constructive activities. Funding received will be used to purchase sports equipment, clothes, shoes, field trips and for prizes to disadvantaged youth.
