SUBJECT: State Contract for Invasive Weed Control – Northern Sierra Program
February 1, 2015 through December 30, 2016.

ACTION REQUESTED

Adopt a resolution authorizing the Agricultural Commissioner/Sealer to sign contract #14-0540-SF in the amount of \$30,000 with the California Department of Food and Agriculture for reimbursement for Invasive Weed Control –Northern Sierra Project from February 1, 2015 through December 30, 2016.

BACKGROUND

The California Department of Food and Agriculture (CDFA) provides for reimbursement for various programs under the direction of the Agricultural Commissioner/Sealer of Weights and Measures to help offset the costs to counties for enforcing mandated programs.

Under this contract, the County will be reimbursed up to a maximum of \$30,000 from February 1, 2015 through December 30, 2016 for participating in the State's Invasive Weed Control – Northern Sierra Project for prevention and/or control of noxious weeds, to improve forest health in the Tahoe Basin and upper Truckee, Yuba, Bear and American River watersheds in the Sierra Nevada Mountains.

ENVIRONMENTAL

This activity does not qualify as a project under the California Environmental Quality Act (CEQA).

FISCAL IMPACT

This revenue reimbursement is for an ongoing program and has no impact on the General Fund.
