**ACTION REQUESTED**

Adopt a resolution authorizing the Agricultural Commissioner/Sealer to sign revised contract #14-0148 for reimbursement in the amount of \$97,916 with the California Department of Food and Agriculture for enforcement of the mandated Exotic Pest Detection Trapping Program for the Fiscal Year 2014-15.

**BACKGROUND**

The California Department of Food and Agriculture (CDFA) provides for reimbursement for various programs under the direction of the Agricultural Commissioner/Sealer of Weights and Measures to help offset the costs to counties for enforcing mandated programs. In the past, the Asian Citrus Psyllid program was issued under a separate contract but is now included in the Exotic Pest Detection Trapping Program.

**ENVIRONMENTAL**

This activity does not qualify as a project under the California Environmental Quality Act (CEQA).

**FISCAL IMPACT**

This contract provides for \$97,916 in reimbursement to offset the Agriculture Department's impact to the General Fund. Funding for this contract is in the Agricultural Commissioner's 2014-15 budget.
