BACKGROUND/COMMUNITY BENEFITS

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants therefore a benefit results to the County.

The Board of Supervisors is being asked to approve appropriations to the Auburn Chamber of Commerce Foundation's *Leadership Auburn Class of 2015*. Leadership Auburn, a non-profit group founded by Auburn Chamber of Commerce Foundation, is designed to identify and empower current and future leaders from all segments of the community who will develop broad knowledge and experience, and help create a spirit of cooperation to effectively address future community challenges. Leadership Auburn is a twelve month class that promotes community members to learn about their communities, strives to broaden participants' experiences by acquainting them with processes, programs and problems that exist in the community, stimulate interest in community activities, encourage participation in community affairs, and introduce emerging leaders to each other and to the current leadership in the community. Each year Leadership Auburn completes a project to give back to the community. This year's project is to remodel Gate 2 of the Gold Country Fairgrounds off Auburn Folsom Road to match the recently remodeled Gate 1 entrance. Funding received will be used for signage, and to redo the arch, widen the opening, and add a walkway and landscaping.
