**Action Requested**

Approve a Budget Revision to move \$27,952 within the Sheriff's FY 2014-15 Final Budget to purchase a protective bomb suit for the Sheriff's Office, authorize the Purchasing Manager to execute all related documents, and add the equipment to the Master Fixed Asset List.

**Background**

The Placer County Sheriff's Office Explosive Ordnance Disposal (E.O.D.) Unit is an accredited Bomb Squad recognized by the U.S. Department of Justice, Federal Bureau of Investigation, Hazardous Devices School, and the National Bomb Squad Commanders Advisory Board. Mandatory equipment for all accredited bomb squads includes two full-coverage bomb suits compatible with Self-Contained Breathing Apparatus (SCBA) and chemical protective suits.

In accordance with current agreements, the Sheriff's E.O.D. Unit is responsible for handling hazardous devices in Placer County, Nevada County and Sierra County. Additionally, the Sheriff's E.O.D. Unit is a member of the Sacramento Regional E.O.D. Unit.

The E.O.D. Unit currently has three bomb suits, two of which are in excess of 15 years old and have exceeded their expected useful life. In order to remain in compliance with national accreditation requirements, one of two expired bomb suits must be replaced.

**Fiscal Impact**


