BACKGROUND

On May 12, 2009 your Board approved the formation of The Placer County Youth Commission as an advisory body to the Board of Supervisors. Following a full year of operations, your Board approved three at-large alternate members on August 10, 2010. The stated purpose of the Placer County Youth Commission is to integrate youth voice into local policymaking and engage the community to create positive change. The Commission is also tasked with organizing activities to help educate and motivate youth of Placer County to participate in the local political process. Commissioner recommendations were made through an application and interview process conducted by a nominating committee composed of two adult advisors for the Commission, four former Youth Commissioners, and one Ambassador.

DRAFT PLACER COUNTY YOUTH COMMISSION

PURPOSE: The Placer County Youth Commission integrates the youth voice into local policymaking by researching youth issues and concerns, relating their findings and positions to local policy makers, and engaging the community to create positive change. The Commission shall organize activities to help educate and motivate youth of Placer County to participate in the local political process.

CONFLICT OF INTEREST: No

COMPOSITION: The Placer County Youth Commission will consist of fifteen (15) primary members and three (3) alternate members who shall be youth between 14-21 years of age, except that a youth that has not reached the age of 14 but is entering the 9th grade may be appointed. There shall be at least one (1) member from each supervisory district. An individual may sit for a maximum of four full terms, except that anyone who turns 22 years of age during their term may not be re-appointed.

MEETINGS: September through June Two evening meetings a month consisting of:
One Commission Business meeting will be held on the 2nd Wednesday of each month from 6:00-8:00 pm in Placer County Board of Supervisors Chambers

One Subcommittee Meeting will be held on the 4th Wednesday of each month from 6:00-8:00 pm generally in the Rocklin Library Community Room.

COMPENSATION: All members of this commission shall serve without compensation.
